Mr. Seraphim was a Consultant with McKinsey & Company and worked on engagements for Fortune 500 clients and the Central Bank of Kuwait. He started his business career in Corporate Development at Canadian Pacific Ltd, Montreal, Canada. Prior to that he was a research scientist at Rochester University on contract from the Office of Naval Research, Arlington, VA. Mr. Seraphim is and has been a board member of a number of companies and organizations, such as The Park Avenue Bank NA, Norr Engineering Ltd., Bon Secours Hospital (Michigan), Hoffco, Inc., SPC Inc., Standard Precast, Precast Concrete Systems, St. Catherine's College (Oxford) Foundation, and Association for Corporate Growth, NY Chapter.
